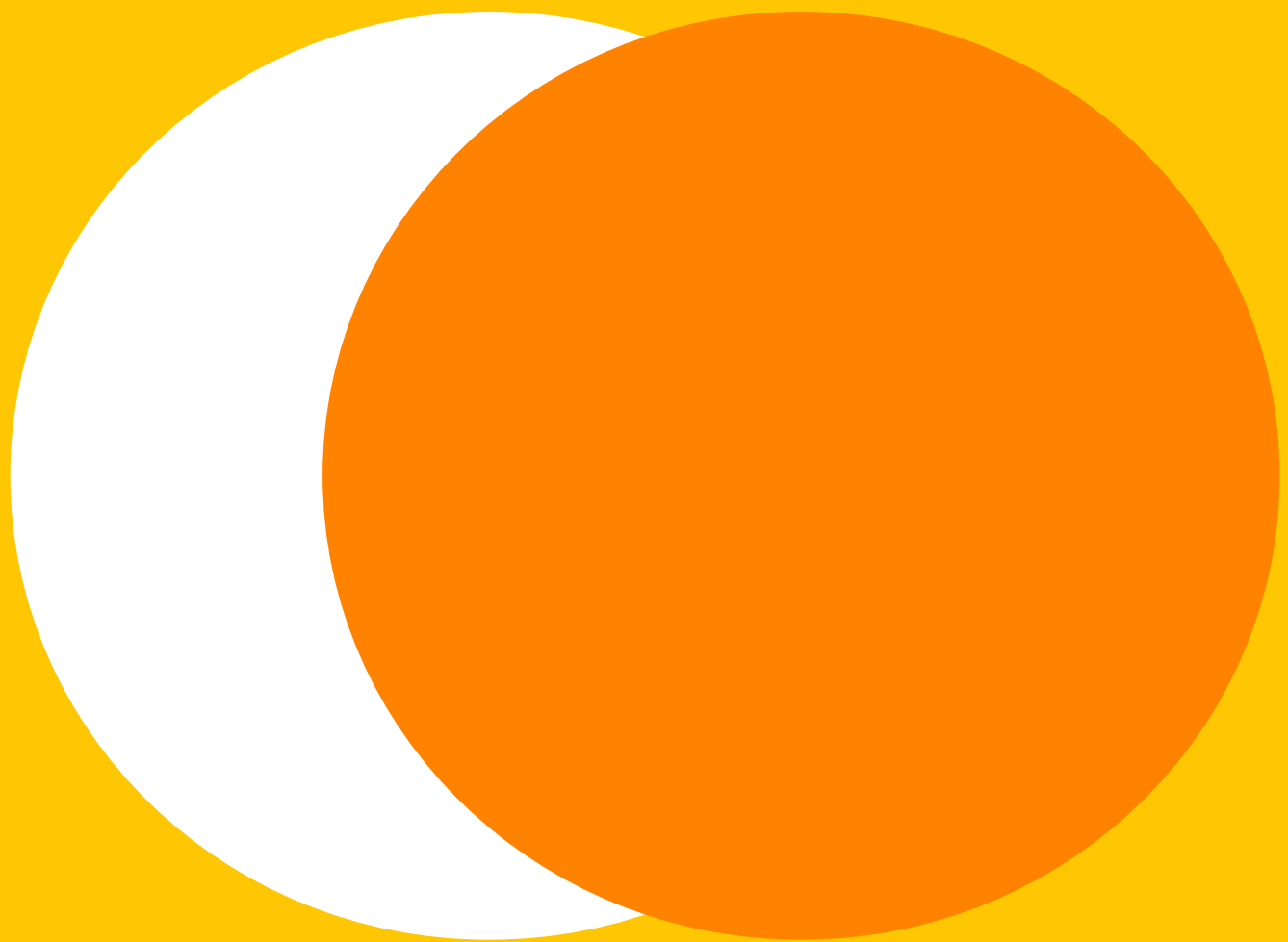

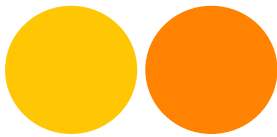

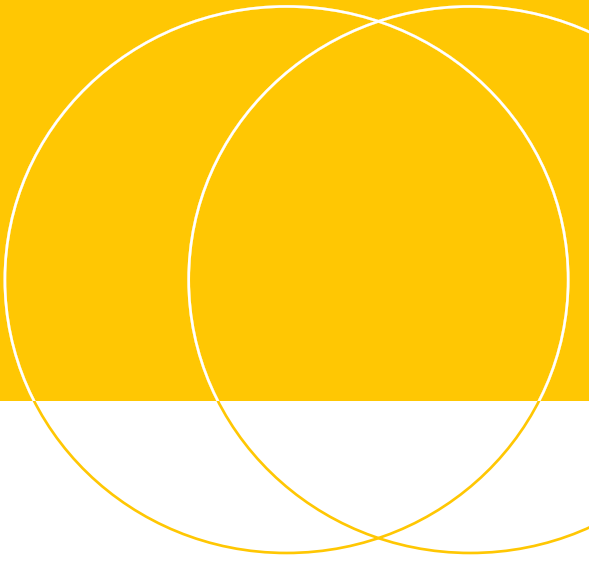

DEVELOPED FROM COLLABORATIVE RESEARCH EXCELLENCE**

Indonesia is the largest economy in Southeast Asia, the third largest democracy in the world and is home to the largest population in the region. However, its potential has not been matched with a robust tradition of scholarship that is able to compete with that of neighbouring countries. Indonesia is even considered one of the countries least effective in explaining itself to the world. As such, it lacks a reputation for producing social science publications that utilise cutting-edge, comparative approaches that benefit society.

The Asia Research Centre, Universitas Indonesia (ARC UI) was established to address this issue. ARC UI is a hub between disciplines, faculties and universities in Asia within the social sciences and humanities, as well as civil society organisations. It aims to become an academically rigorous organisation that nurtures deep interdisciplinary research, which can be scaled up across the whole university and engage in high level international and inter-sectoral collaborations.

DIRECTOR'S NOTE

The Asia Research Centre, Universitas Indonesia (ARC UI) was founded in 2020 in response to a health crisis. Those who strongly supported its formation had in mind the need for social sciences and the humanities to play a greater role in understanding how states and societies survive, evolve, or stagnate amid great pressures and crises. Our flagship multiyear, multi-country studies on COVID-19 in Asia, which commenced in 2021, opened up a way for academics to do this in a collaborative way.

But if there is one thing we learned from the role of social sciences and humanities in Asia during the pandemic, it is that moments of crisis have come in so many forms for so long. Everyday crises can be seen in any city in Asia and more globally where development has been uneven, leading to the formation of slums, often followed subsequently by evictions of their inhabitants. They can be seen also in the experiences of precarious workers with insecure employment, as well as low waged female workers who carry out unpaid care work. So many studies confirm our own: that rapid urbanisation and ambitions of economic growth have given rise to both wealth and sharp social inequalities. The COVID-19 pandemic brought all these to the surface for us to see more blatantly.

There is another matter of how we find ways to identify and address impending crises. Which crisis do we prioritise to address?



Governments and societies around the world have shown greater awareness of the growing climate crisis. More attention is being given to countries home to the largest remaining rainforests in the world (i.e., Brazil, Congo and Indonesia). The links have become more obvious between extreme climate change, the emergence of new kinds of infectious diseases, the worsening quality of our food and water, and the uprooting of people from the land

Scientific theories and methods have been developed all over the world to understand these multi-layered issues. But universities and academic publication outlets, like bureaucracies, tend to work within disciplinary and administrative silos. The silos have become so ingrained in the way knowledge is produced that encouraging a kind of interdisciplinary willingness to recognise the complexities and inherent contradictions within crises is itself an immense task. Not only has research funding been inadequate across most of the world to address current and imminent crisis, even countries with the oldest and most established universities are experiencing employment cuts alongside the acceleration of individualisation and competition that often discourages interdisciplinary cooperation.

But our research and experience in 2022 have taught us that meaningful interdisciplinary work can respond to multidimensional crises if it identifies clear priority issues; and the academics involved are not only well-trained in their field but also have the kind of social and intellectual imaginations that enable different specialisations to thrive in conjunction with each other without prejudice or bias. After looking at the progress of various interdisciplinary research groups we have hosted, which have modified their methods to answer an agreed set of research questions, we are convinced that interdisciplinarity is not only viable but also the prerequisite to finding ways out of crises situations that we all face in common.

This is the strength of social sciences and the humanities. For us, every social and cultural context is a space for analysis and to practice reflexivity—an opportunity to examine our own judgements and beliefs. After all, we are trained to unpack power relations and try as much as possible to modify situations in ways that, we fervently believe, benefit those most impacted by the crises we write and speak about.

Simply put, the key is to do our jobs as well and as meaningfully as conditions permit. We do this within a specific social and institutional context and with the limited resources we have, with the aim of producing the highest academic quality research and extending their results to the widest public spaces possible. We must also think about nurturing future generations of researchers: we write and publish to have something to pass on to present-day early career academics in Indonesia and Asia, so that they are better equipped to cope with the ever-changing social world.

All this would not have been possible without our collaborations with actors and organisations who are also willing to institutionalise meaningful academic labour. Like us, they have been going against the grain by putting in energy and resources to widen the space for more academics to “de-alienate” themselves (nurture a sense of belonging to a collective and being of use to others in need). While our findings often exhibit what might be called a pessimism of the intellect, not going through the journey in isolation, we believe, has helped to shape an optimism of a more collective will.

FIELDWORK HIGHLIGHTS

1. PRODUCING KNOWLEDGE ON ASIA FOR INDONESIA: COVID-19, GOVERNANCE, AND SOCIAL RESILIENCE



Our research team members, Dr. Imam Ardhiyanto (Department of Anthropology, Universitas Indonesia) and Dr. Dave Lumenta (Department of Anthropology, Universitas Indonesia) wants to understand responses to the health crisis in the frontiers of the archipelago. They conducted fieldwork in Nawang Baru, Pujungan, Malinau, Tanjung Selor in North Kalimantan, Indonesia to understand the everyday lives of nomadic and non-nomadic indigenous people. They listened to the stories of communities, traditional leaders, and local government officials (of the health office) to paint a granular picture about experiences with the pandemic.

2. CHINESE FDI AND LOCAL ENGAGEMENT IN INDONESIA: TRENDS, INTERACTIONS, AND ADAPTATIONS



Lead researcher Dr. Suraya Afiff (Department of Anthropology, Universitas Indonesia), supporting researcher, Dr. Yeremia E. Lalisang (Department of International Relations, Universitas Indonesia) and research manager M. Irvan (Asia Research Centre, Universitas Indonesia) listened to the experiences of communities, company workers, and local officials in two locations: West Java and Kalimantan. They explore how Chinese investments link with local experiences.

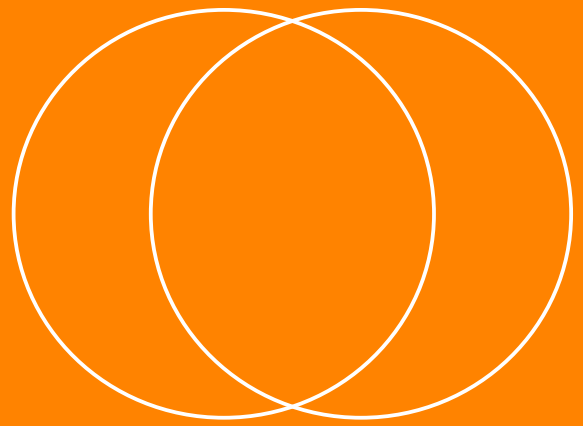
FIELDWORK HIGHLIGHTS

3. RESILIENCE AND ADAPTATION TO SEA LEVEL RISE IN JAKARTA BAY: SINK OR SWIM TOGETHER?



Our research team visited Cilincing and Sunda Kepala, North Jakarta, Indonesia, to conduct preliminary research to develop a clear framework for the three-year research. We wanted to understand how, on an everyday level, resilience and adaptation are formed in response to climate change in the coastal areas of megapolitan Jakarta. We began unpacking the contractions within conflict and cooperation between unequal social classes and groups.

CAPACITY BUILDING



1. BUILDING ACADEMIC CAPACITY

We commit to building academic capacity, and we do this through academic mentoring and international research collaboration. We are proud to host our first Postdoctoral Fellowship and Visiting Research Fellowship Program.

The main goal of the Postdoctoral Fellowship Program is to develop their professional and academic skills while still under the mentorship of experienced researchers.

Our Visiting Research Fellowship aims to help PhD students around the world whose dissertation is about Indonesia in comparison to global changes to conduct their field research. The visiting research fellows are hosted by a senior academic who helps them navigate fieldwork challenges.

Postdoctoral Fellow : Dr. phil. Geger Riyanto (Asia Research Centre, Universitas Indonesia)

Academic Host : Dr. Inaya Rakhmani (Asia Research Centre, Universitas Indonesia)

Geger Riyanto is a postdoctoral researcher at the Asia Research Centre, University of Indonesia. He teaches in the Department of Anthropology at the University of Indonesia and is an editor at Remotivi. His interests are in intergroup relations. His anthropological writings have been published in journals such as Oceania, Indonesia and the Malay World, Anthropos, Zeitschrift für Ethnologie, and media outlets such as Remotivi, IndoProgress, Deutsche Welle, and Inside Indonesia.

Geger Riyanto is involved in an ARC UI's LIFE project that focuses on the relationship between deforestation and poverty. The research delves into the relationship between changes in biodiversity and livelihood aspirations. Deforestation is a widespread issue globally, and its persistence at an alarming rate is not due to a single cause. Some attribute it to poverty leading local communities to engage in unsustainable agricultural practices, while others blame extractive interests as the primary driver of deforestation. We aim to take a different approach by first examining the livelihood aspirations of forest communities. By doing so, we hope to provide a clearer picture of the connections between people, and how the trend impacts their lives.

Visiting PhD Fellow : Mirna Nadia (Northwestern University, Illinois, United States)

Academic Host : Dr. Diana Pakasi (Department of Sociology, Universitas Indonesia)

Mirna is a sociology Ph.D. candidate at Northwestern University. She is interested in the entanglements between gender and sexuality, the durability of institutions that serve as models for our social relations and exchange, and their transformative potential. Her research examines why a part of marginalised groups that do not conform to the dominant model of family is able to obtain state facilitation while others are met with resistance and subjected to state repression

Selçuk Köseoğlu has long been interested in Turkey's social and religious transformations that have taken place before and during the current government; he decided to pursue a graduate degree for further research. He is now a Political Science PhD candidate at the University of Minnesota, trying to understand the Indonesian context he reads in literature. He used his relationship with ARC UI to connect with scholars working on Islam in Indonesia and the Middle East. Although he did not carry out any fieldwork, he had the opportunity to be part of various informal discussions with our peers in ARC UI to understand about the crowding and fragmentation of Indonesia's religious space, contemporary challenges to traditional Islamic authority, and how the Nahdlatul Ulama handles these processes.

2. STRENGTHENING ACADEMIC EXCHANGE

We collaborate with departments inside and beyond the Faculty of Social and Political Sciences Universitas Indonesia (FISIP UI) and have increased inbound and outbound mobility by holding public lectures, hybrid and online seminars, and roundtable discussions.

- Together with the Department of International Relations at the FISIP UI, we invited Professor Michael Wesley, a professor of International Relations at the University of Melbourne, Australia, to give a public lecture on the impact of the war in Ukraine on Asia
- In collaboration with the FISIP UI's Research, Publication, and Social Services Manager; Department of Anthropology and Department of International Relations at the FISIP UI, we invited Professor Tania Li, a professor of anthropology at the University of Toronto, Canada. In her serial visit, Prof Tania Li presented in a roundtable discussion about the future of oil palm plantations in Indonesia, and talked about conducting research with the social justice agenda(s).
- Together with the PUSKAPOL (Center for Political Studies) Universitas Indonesia, POLGOV UGM (Research Center for Politics and Government at Universitas Gadjah Mada), and Kurawal Foundation; we invited Professor Anders Uhlin. Prof Uhlin is a professor of Political Science at Lund University, Sweden. With his expertise, he voices his recommendation about the research roadmap for FISIP UI. Besides, Prof Uhlin gave a public lecture on the (de)legitimation of ASEAN and international organisations. Together with his colleague from Lund University, Dr Astrid Noren-Nilsson; and from POLGOV UGM, Dr Amalinda Savirani; he presented about civil society elites in Indonesia and Cambodia.



We collaborated with colleagues from the University of Melbourne, Australia to hold the 41st Indonesia Postgraduate Network Symposium. In this hybrid symposium held in Melbourne, the Director of ARC UI, Dr Inaya Rakhmani acted as chair of a panel entitled "Media, Power, and Political Manipulation in Indonesia's Reform Era". She was also one of speakers at a special roundtable discussion about publishing research, together with some colleagues including ARC UI's research fellows, Dr Ariane Utomo and Dr Annisa Beta.



We attended a conference on "South Asian Labor Migration and Maritime Migrants" in Kathmandu, Nepal. The conference was organised by The Calcutta Research Group and the Institute for Human Sciences, Vienna [under the project "Justice, Protection and Government of the People: A Two- Year Research and Orientation Programme on Protection and Democracy in a Post-COVID World (2021-2023)] in collaboration with the Nepal Institute of Peace and Alliance for Social Dialogue. Our research fellows Dr Robertus Robet and Rhino Ariefiansyah presented about migrations to and from Indonesia. The session focused on the vulnerabilities faced by refugees and migrant workers in Indonesia. The first discussion focused on the migration paradox shown by Indonesia. The second discussion explored the crucial role played by migration in substituting and supporting agricultural activities in Java.



We, represented by our fellows Dr Inaya Rakhmani and Dr Diatyka Widya Permata Yasih, joined a workshop on Emerging Muslim Lifestyles in Maritime Southeast Asia Impact on Multicultural Societies in ISEAS Yusof Ishak Institute Singapore. Inaya and Diatyka talked about the Resisting and Reproducing Neoliberal Capitalism: A Case Study of Muslimah Labourers in Central Java, Indonesia; in a panel titled Shariah and Advocacy Groups. They underlined that working-class women of the Muslim faith, who are among Indonesia's most vulnerable and lack access to public healthcare and other services, have something to teach the powers that be about true Islamic governance.



We contributed to the AIFIS-MSU Conference organised by the American Institute for Indonesian Studies (AIFIS) and Michigan State University. In this online conference, our research fellows discussed in a panel on Developing Asian Studies for Indonesia. Dr Suraya Afiff and Dr Ardhitya Eduard Yeremia talked about their research on Chinese investment in Indonesia's environment sector. Dr Evi Eliyanah and Dr Zulfa Sakhiyya presented their research on gender inequalities in Southeast Asian higher education, specifically in the Indonesian context. Prof Evi Fitriani and Dr Sartika Soesilowati talked about their research on Asian countries' strategies to cope with the Covid-19 pandemic. This panel mainly aims to develop a comparative perspective on Asia from Indonesia and highlight the urgency of research collaboration.



We participated in a discussion held by the International Development Research Centre (IDRC)'s The Knowledge for Democracy Myanmar (K4DM) in partnership with Global Affairs Canada (GAC), namely KNOWLEDGE MARKETPLACE – Bangkok 2022: Exchanging Ideas for a Democratic Myanmar. The marketplace is an open space to discuss key policy issues from diverse perspectives while promoting gender equality and democratic values. In this event held in Bangkok, our research fellow, Dr Zulfa Sakhiyya, joined a roundtable discussion "Thought leadership to advance knowledge for Myanmar: What should come next?".



Our research fellow, Dr Dave Lumenta and Dr Imam Ardianto, did an archival research in the Netherlands to study the history of health and hygiene politics implemented by the Dutch East Indies government in Indonesia, especially in Kalimantan. The data would be compared to the politics as well as the implementation in the post colonial era, especially in the context of Covid-19 pandemic in Indonesia.

ASIA RESEARCH CENTRE, UNIVERSITAS INDONESIA (ARC UI) ADALAH PUSAT PENELITIAN LINTAS DISIPLIN YANG DIDIRIKAN UNTUK MEMPERKUAT TATA KELOLA DAN RESILIENSI SOSIAL, DI TINGKAT GLOBAL, REGIONAL, NASIONAL, MAUPUN LOKAL, MELALUI ANALISIS KOMPARATIF YANG DIKEMBANGKAN DARI PENELITIAN KOLABORATIF

Indonesia adalah negara dengan ekonomi terbesar di Asia Tenggara, negara demokrasi terbesar ketiga di dunia, dan negara dengan populasi terbesar di kawasan Asia Tenggara. Namun demikian, potensinya belum diimbangi dengan tradisi keserjanaan yang kuat, yang mampu bersaing dengan negara tetangga. Indonesia bahkan dianggap sebagai salah satu negara yang paling tidak efektif dalam menjelaskan dirinya kepada dunia. Tidak mengherankan, Indonesia kurang memiliki reputasi dalam menghasilkan publikasi ilmu sosial yang menggunakan pendekatan komparatif mutakhir, yang juga bermanfaat bagi masyarakat.

Asia Research Centre, Universitas Indonesia (ARC UI) didirikan untuk menjawab tantangan tersebut. ARC UI merupakan penghubung berbagai disiplin ilmu, fakultas dan universitas dalam ilmu sosial dan humaniora, dan juga masyarakat sipil, di Asia. ARC UI bertujuan untuk menjadi organisasi akademik yang mampu mengembangkan penelitian lintas disiplin secara mendalam, yang dapat ditingkatkan ke tingkat universitas, dan terlibat dalam kolaborasi internasional dan antar-sektor.

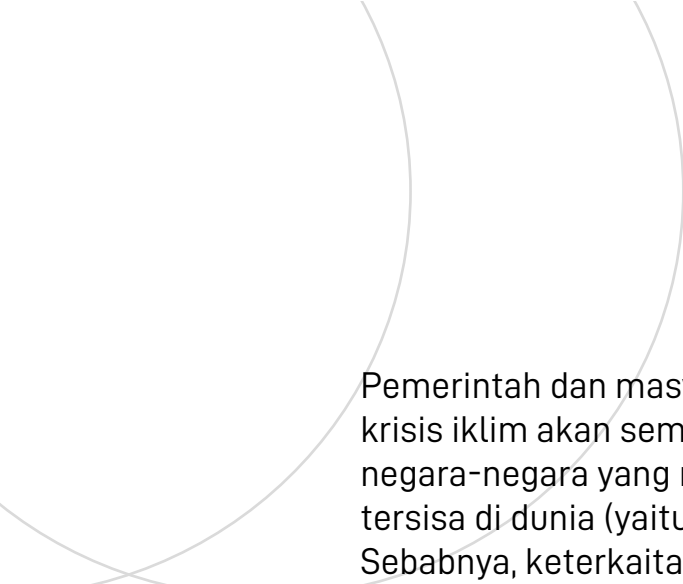

CATATAN DIREKTUR

Asia Research Centre, Universitas Indonesia (ARC UI) didirikan pada tahun 2020 sebagai respon terhadap krisis kesehatan. Para pendukung utama pembentukan ARC UI melakukannya karena merasa betapa pentingnya ilmu sosial dan humaniora dalam memahami bagaimana negara dan masyarakat bertahan, berkembang, atau mandek di tengah tekanan dan krisis yang hebat. Studi multi-negara unggulan kami tentang pandemi COVID-19 di Asia, yang dimulai pada tahun 2021, telah membuka jalan bagi para akademisi untuk melakukan hal ini dengan cara yang kolaboratif.

Jika ada satu pelajaran yang bisa kami petik dari peran ilmu sosial dan humaniora di Asia selama pandemi, adalah bahwa momen krisis telah hadir jauh sebelum pandemi dan ada dalam begitu banyak bentuk. Krisis sehari-hari dapat dilihat di kota mana pun di Asia dan di seluruh dunia di mana pembangunan tidak merata. Di sini kita melihat menjamurnya kawasan kumuh, yang kemudian disusul dengan penggusuran. Krisis sehari-hari juga kami lihat dalam pengalaman pekerja bukan penerima upah, tanpa kepastian kerja, serta buruh perempuan berupah rendah yang melakukan pekerjaan mengasuh keluarga yang tentunya tidak dibayar. Begitu banyak riset lain mengkonfirmasi temuan kami: bahwa urbanisasi yang pesat dan ambisi pertumbuhan ekonomi telah menciptakan ketimpangan kekayaan dan sosial yang tajam. Pandemi COVID-19 membawa semua ini ke permukaan untuk kita lihat lebih terang-terangan.

Lalu bagaimana kita bisa menemukan cara untuk mengidentifikasi dan mengatasi krisis yang akan datang. Krisis mana yang kita prioritaskan untuk diatasi?



Pemerintah dan masyarakat di seluruh dunia semakin sadar bahwa krisis iklim akan semakin parah. Perhatian politik global kepada negara-negara yang memiliki hutan tropis terbesar yang masih tersisa di dunia (yaitu, Brasil, Kongo, dan Indonesia) semakin tinggi. Sebabnya, keterkaitan antara perubahan iklim yang ekstrim, munculnya penyakit menular jenis baru, memburuknya kualitas makanan dan air kita, dan tercerabutnya manusia dari lahan menjadi lebih jelas.

Teori dan metode ilmiah telah dikembangkan di seluruh dunia untuk memahami masalah berlapis-lapis ini. Tetapi universitas dan saluran publikasi akademik, seperti halnya birokrasi, cenderung bekerja dalam sekat disiplin dan administrasi. Sekat ini sudah begitu tertanam dalam produksi pengetahuan sehingga sekadar mendorong kemauan interdisipliner untuk mengenali kompleksitas dan kontradiksi yang melekat dalam krisis itu sendiri merupakan tugas yang sangat berat. Pendanaan penelitian untuk mengatasi krisis saat ini dan yang akan segera terjadi juga tidak memadai, bukan cuma di Indonesia tapi di seluruh dunia. Bahkan, negara-negara dengan universitas tertua dan paling mapan pun mengalami pemutusan hubungan kerja bersamaan dengan percepatan individualisasi dan persaingan yang sering menghambat kerja sama interdisipliner.

Inilah kekuatan ilmu sosial dan humaniora. Bagi kami, setiap konteks sosial dan budaya adalah ruang untuk analisis dan praktik refleksif—kesempatan untuk mempertanyakan ulang penilaian dan keyakinan kita sendiri. Lagi pula, kita dilatih secara akademik untuk membongkar hubungan kekuasaan dan mencoba sebisa mungkin memodifikasi situasi dengan cara yang, kami sangat percaya, menguntungkan mereka yang paling terkena dampak krisis yang kita tulis dan bicarakan.

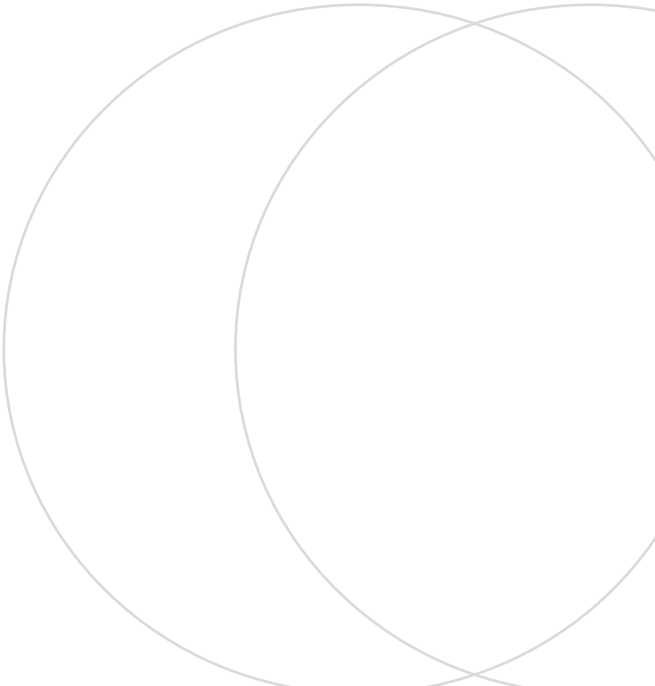
Sederhananya, kuncinya adalah melakukan pekerjaan kita sebaik dan sebermanakna mungkin sejauh kondisi memungkinkan. Kami melakukan ini dalam konteks sosial dan kelembagaan yang ada dan dengan sumber daya terbatas yang kami miliki, dengan tujuan menghasilkan penelitian akademik dengan kualitas setinggi yang kami bisa dan memperluas hasilnya ke ruang publik seluas mungkin. Kita juga senantiasa menemani generasi akademisi masa depan: tulisan dan terbitan kami sebenarnya adalah alat untuk akademisi karir awal di Indonesia dan Asia masa kini, supaya mereka lebih siap menghadapi dunia sosial yang terus berubah.

Semua ini tidak akan mungkin terwujud tanpa kolaborasi kami dengan para aktor dan organisasi yang juga bersedia melembagakan kerja akademis yang bermakna. Sebagaimana halnya kami, mereka juga harus melawan arus dengan mengalokasikan energi dan sumber daya demi memperluas ruang bagi lebih banyak akademisi untuk melakukan "de-alienasi" (memupuk rasa menjadi bagian dari sebuah kolektif dan berguna bagi orang yang membutuhkan). Temuan kami mungkin kerap diwarnai oleh apa yang disebut pesimisme intelektual. Tapi, karena kami tidak melalui perjalanan ini sendirian, kami yakin, kerja akademik yang kami lakukan berangsur membentuk optimisme kemauan yang kolektif.

1. PRODUKSI PENGETAHUAN DI ASIA UNTUK INDONESIA: COVID-19, TATA KELOLA, DAN KETAHANAN SOSIAL



Anggota tim peneliti kami, Dr. Imam Ardhianto (Departemen Antropologi Universitas Indonesia) dan Dr. Dave Lumenta (Departemen Antropologi Universitas Indonesia), ingin memahami respons terhadap krisis kesehatan di perbatasan nusantara. Mereka melakukan kerja lapangan di Nawang Baru, Pujungan, Malinau, Tanjung Selor di Kalimantan Utara, Indonesia, untuk memahami kehidupan sehari-hari masyarakat adat nomaden dan non-nomaden. Mereka mendengarkan cerita masyarakat, tokoh adat, dan aparat pemerintah daerah (dinas kesehatan) untuk melukiskan gambaran granular pengalaman menghadapi pandemi.

2. INVESTASI LANGSUNG LUAR NEGERI CINA DAN KETERLIBATAN LOKAL DI INDONESIA: TREN, INTERAKSI, DAN ADAPTASI



Peneliti utama Dr. Suraya Afiff (Departemen Antropologi, Universitas Indonesia), peneliti pendukung Dr. Yeremia Lalisang (Departemen Hubungan Internasional, Universitas Indonesia) dan manajer penelitian M. Irvan (Asia Research Centre, Universitas Indonesia) menyimak pengalaman masyarakat, pekerja perusahaan, dan pejabat lokal di dua lokasi: Jawa Barat dan Kalimantan. Mereka mengeksplorasi bagaimana investasi Tiongkok berhubungan dengan pengalaman lokal.

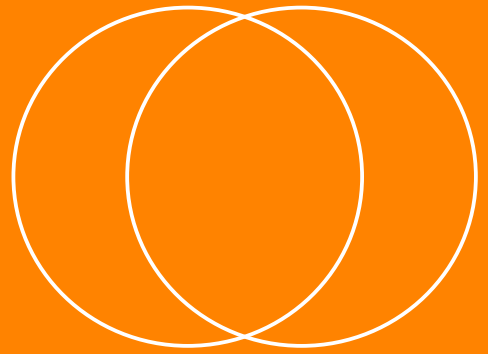

3. RESILIENSI DAN ADAPTASI KENAIKAN PERMUKAAN LAUT DI TELUK JAKARTA: TENGCELAM ATAU BERENANG BERSAMA?



Tim peneliti kami mengunjungi Cilincing dan Sunda Kepala, Jakarta Utara, Indonesia, untuk melakukan penelitian pendahuluan guna mengembangkan kerangka kerja yang jelas untuk penelitian tiga tahun tersebut. Kami ingin memahami bagaimana, pada tataran sehari-hari, ketahanan dan adaptasi terbentuk sebagai respons terhadap perubahan iklim di kawasan pesisir megapolitan Jakarta. Kami mulai membongkar kontraksi dalam konflik dan kerja sama antara kelas dan kelompok sosial yang tidak setara.

PENGEMBANGAN KAPASITAS



1. MEMBANGUN KAPASITAS AKADEMIK

Kami berkomitmen membangun kapasitas akademik, dan kami melakukannya melalui pendampingan akademik dan kolaborasi penelitian internasional. Kami bangga menjadi tuan rumah Program Postdoctoral Fellowship dan Visiting Research Fellowship pertama kami.

Tujuan utama Postdoctoral Fellowship Program adalah untuk mengembangkan keterampilan profesional dan akademik mereka sambil tetap berada di bawah bimbingan para peneliti berpengalaman.

Visiting Research Fellowship kami bertujuan untuk membantu mahasiswa doktoral di seluruh dunia yang disertasinya tentang Indonesia dibandingkan dengan perubahan global untuk melakukan penelitian lapangan mereka. Rekan peneliti tamu dipandu oleh seorang akademisi senior yang membantu mereka menavigasi tantangan kerja lapangan.

Postdoctoral Fellow : Dr. phil. Geger Riyanto (Asia Research Centre, Universitas Indonesia)

Academic Host : Dr. Inaya Rakhmani (Asia Research Centre, Universitas Indonesia)

Geger Riyanto adalah peneliti postdoctoral di Asia Research Centre, Universitas Indonesia. Ia mengajar di Departemen Antropologi Universitas Indonesia dan menjadi editor di Remotivi. Minatnya adalah mengenai hubungan antarkelompok. Tulisan-tulisan antropologinya telah diterbitkan di jurnal-jurnal seperti Oceania, Indonesia and the Malay World, Anthropos, Zeitschrift für Ethnologie, dan media massa seperti Remotivi, IndoProgress, Deutsche Welle, dan Inside Indonesia.

Geger Riyanto terlibat dalam penelitian kami yang bernama LIFE, yang berfokus pada hubungan antara deforestasi dan kemiskinan. Penelitian kami menyelidiki hubungan antara perubahan keanekaragaman hayati dan aspirasi penghidupan. Deforestasi adalah masalah yang tersebar luas secara global, dan determinasinya pada tingkat yang mengkhawatirkan bukan disebabkan oleh satu penyebab. Beberapa mengaitkannya dengan kemiskinan yang menyebabkan masyarakat lokal terlibat dalam praktik pertanian yang tidak berkelanjutan, sementara yang lain menyalahkan kepentingan ekstraktif sebagai pendorong utama deforestasi. Kami bertujuan untuk mengambil pendekatan yang berbeda dengan terlebih dahulu memeriksa aspirasi penghidupan masyarakat hutan. Dengan demikian, kami berharap dapat memberikan gambaran yang lebih jelas tentang hubungan antar manusia, dan bagaimana tren tersebut memengaruhi kehidupan mereka.

Visiting PhD Fellow : Mirna Nadia (Northwestern University, Illinois, United States)

Academic Host : Dr. Diana Pakasi (Departemen Sosiologi, Universitas Indonesia)

Mirna adalah seorang kandidat doktor sosiologi di Northwestern University. Ia tertarik pada keterikatan antara gender dan seksualitas, daya tahan institusi yang berfungsi sebagai model untuk hubungan dan pertukaran sosial kita, dan potensi transformatifnya. Penelitiannya mempelajari mengapa sebagian dari kelompok terpinggirkan yang tidak sesuai dengan model dominan keluarga dapat memperoleh fasilitas negara sementara yang lain menghadapi perlawanan dan mengalami represi negara.

Ary Hermawan adalah kandidat doktor di Asia Institute, University of Melbourne. Ia memperoleh gelar master dalam jurnalisme internasional dari School of Journalism, Arizona University. Minat penelitiannya meliputi media digital, hak asasi manusia, agama dan politik.

Selçuk Köseoğlu telah lama tertarik dengan transformasi sosial dan keagamaan Turki yang terjadi sebelum dan selama pemerintahan saat ini; ia memutuskan untuk mengejar gelar sarjana untuk penelitian lebih lanjut. Ia kini menjadi kandidat PhD Ilmu Politik di University of Minnesota, yang mencoba memahami konteks Indonesia yang ia baca dalam literatur. Dia menggunakan hubungannya dengan ARC UI untuk terhubung dengan para sarjana yang bekerja tentang Islam di Indonesia dan Timur Tengah. Meski tidak melakukan kerja lapangan, ia berkesempatan menjadi bagian dari berbagai diskusi informal dengan rekan-rekan kami di ARC UI untuk memahami tentang kepadatan dan fragmentasi ruang keagamaan di Indonesia, tantangan kontemporer terhadap otoritas Islam tradisional, dan bagaimana Nahdlatul Ulama menangani proses-proses ini.

- Bersama Departemen Hubungan Internasional FISIP UI, kami mengundang Profesor Michael Wesley, seorang profesor Hubungan Internasional di University of Melbourne, Australia, untuk memberikan kuliah umum tentang dampak perang di Ukraina terhadap Asia.
- Berkolaborasi dengan Manajer Riset, Publikasi, dan Pengabdian Masyarakat FISIP UI; Departemen Antropologi dan Departemen Hubungan Internasional FISIP UI, kami mengundang Profesor Tania Li, seorang profesor antropologi di University of Toronto, Kanada. Dalam rangkaian kunjungannya, Prof Tania Li mempresentasikan dalam diskusi meja bundar tentang masa depan perkebunan kelapa sawit di Indonesia, dan berbicara tentang melakukan penelitian dengan agenda keadilan sosial.
- Bersama dengan PUSKAPOL (Pusat Kajian Politik) Universitas Indonesia, POLGOV UGM (Pusat Kajian Politik dan Pemerintahan Universitas Gadjah Mada), dan Yayasan Kurawal; kami mengundang Profesor Anders Uhlin. Prof Uhlin adalah profesor Ilmu Politik di Lund University, Swedia. Dengan keahliannya, ia menyuarakan rekomendasinya tentang peta jalan penelitian FISIP UI. Selain itu, Prof Uhlin memberikan kuliah umum tentang (de)legitimasi ASEAN dan organisasi internasional. Bersama rekannya dari Lund University, Dr Astrid Noren-Nilsson; dan dari POLGOV UGM, Dr Amalinda Savirani; dia berbicara tentang elit masyarakat sipil di Indonesia dan Kamboja.



Kami berkolaborasi dengan rekan-rekan dari University of Melbourne, Australia untuk mengadakan 41st Indonesia Postgraduate Network Symposium. Dalam simposium hybrid yang diadakan di Melbourne ini, Direktur ARC UI, Dr Inaya Rakhmani bertindak sebagai ketua panel berjudul "Media, Kekuasaan, dan Manipulasi Politik di Era Reformasi Indonesia" ("Media, Power, and Political Manipulation in Indonesia's Reform Era"). Ia juga menjadi salah satu pembicara pada diskusi meja bundar khusus tentang penelitian penerbitan, bersama dengan beberapa rekan termasuk peneliti ARC UI, Dr Ariane Utomo dan Dr Annisa Beta.



Kami menghadiri konferensi tentang "Migrasi Buruh Asia Selatan dan Migran Maritim" ("South Asian Labor Migration and Maritime Migrants") di Kathmandu, Nepal. Konferensi tersebut diselenggarakan oleh The Calcutta Research Group dan Institute for Human Sciences, Vienna [di bawah proyek "Keadilan, Perlindungan dan Pemerintahan Rakyat: Program Riset dan Orientasi Dua Tahun tentang Perlindungan dan Demokrasi di Dunia Pasca-COVID (2021–2023)] bekerja sama dengan Nepal Institute of Peace and Alliance for Social Dialogue. Peneliti kami Dr Robertus Robet dan Rhino Ariefiansyah mempresentasikan tentang migrasi dari dan ke Indonesia. Sesi ini berfokus pada kerentanan yang dihadapi pengungsi dan pekerja migran di Indonesia. Pembahasan pertama terfokus pada paradoks migrasi yang ditunjukkan oleh Indonesia. Diskusi kedua mengeksplorasi peran penting yang dimainkan oleh migrasi dalam menggantikan dan mendukung kegiatan pertanian di Jawa.



Kami, diwakili oleh peneliti kami Dr Inaya Rakhmani dan Dr Diatyka Widya Permata Yasih, mengikuti lokakarya tentang Dampak Munculnya Gaya Hidup Muslim di Maritim Asia Tenggara pada Masyarakat Multikultural (Emerging Muslim Lifestyles in Maritime Southeast Asia Impact on Multicultural Societies) di ISEAS Yusof Ishak Institute Singapore. Inaya dan Diatyka berbicara tentang Melawan dan Mereproduksi Kapitalisme Neoliberal: Studi Kasus Buruh Muslimah di Jawa Tengah, Indonesia; dalam panel bertajuk Kelompok Syariah dan Advokasi. Mereka menggarisbawahi bahwa perempuan kelas pekerja beragama Islam, yang termasuk di antara yang paling rentan dan tidak memiliki akses ke layanan kesehatan publik dan layanan lainnya di Indonesia, memiliki sesuatu untuk diajarkan tentang kekuasaan tentang pemerintahan Islam yang sebenarnya.



Kami berkontribusi pada AIFIS-MSU Conference yang diselenggarakan oleh American Institute for Indonesian Studies (AIFIS) dan Michigan State University. Dalam konferensi daring ini, peneliti-peneliti kami berdiskusi dalam panel Mengembangkan Kajian Asia untuk Indonesia. Dr Suraya Afiff dan Dr Ardhyta Eduard Yeremia berbicara tentang penelitian mereka mengenai investasi China di sektor lingkungan di Indonesia. Dr Evi Eliyanah dan Dr Zulfa Sakhiyya mempresentasikan penelitian mereka tentang ketidaksetaraan gender di pendidikan tinggi Asia Tenggara, khususnya dalam konteks Indonesia. Prof Evi Fitriani dan Dr Sartika Soesilowati berbicara tentang penelitian mereka mengenai strategi negara-negara Asia untuk mengatasi pandemi Covid-19. Panel ini terutama bertujuan untuk mengembangkan perspektif komparatif tentang Asia dari Indonesia dan menyoroti urgensi kolaborasi dalam penelitian.



Kami berpartisipasi dalam diskusi yang diselenggarakan oleh The Knowledge for Democracy Myanmar (K4DM) yang diinisiasi oleh International Development Research Center (IDRC) bekerjasama dengan Global Affairs Canada (GAC), yaitu KNOWLEDGE MARKETPLACE – Bangkok 2022: Exchanging Ideas for a Democratic Myanmar. MARKETPLACE adalah ruang terbuka untuk membahas isu-isu kebijakan utama dari berbagai perspektif sambil mempromosikan kesetaraan gender dan nilai-nilai demokrasi. Dalam acara yang diadakan di Bangkok ini, peneliti kami, Dr Zulfa Sakhiyya, mengikuti diskusi meja bundar "Pemikiran kepemimpinan untuk memajukan pengetahuan bagi Myanmar: Apa yang harus terjadi selanjutnya?" (Thought leadership to advance knowledge for Myanmar: What should come next?).



Peneliti kami, Dr Dave Lumenta dan Dr Imam Ardhiyanto, melakukan penelitian arsip di Belanda untuk mempelajari sejarah politik kesehatan dan kebersihan yang diterapkan oleh pemerintah Hindia Belanda di Indonesia, khususnya di Kalimantan. Data tersebut akan dibandingkan dengan politik serta implementasinya di era pasca kolonial, khususnya dalam konteks pandemi Covid-19 di Indonesia.



Peneliti kehormatan kami, Prof Evi Fitriani berkontribusi sebagai panelis di Webinar RSIS-ANU tentang "Memahami Kehadiran Teknologi China di Indonesia" (Understanding China's Tech Presence in Indonesia). Acara ini diselenggarakan oleh National Security College (Australian National University) dan Future Issues and Technology Research Cluster (RSIS) dengan dukungan dari Center of Excellence for National Security (RSIS). Webinar ini bertujuan untuk memahami kehadiran teknologi China yang berkembang di Indonesia di tengah konteks domestik, regional, dan global yang kompleks, dan mencari implikasi potensial untuk wilayah yang lebih luas.

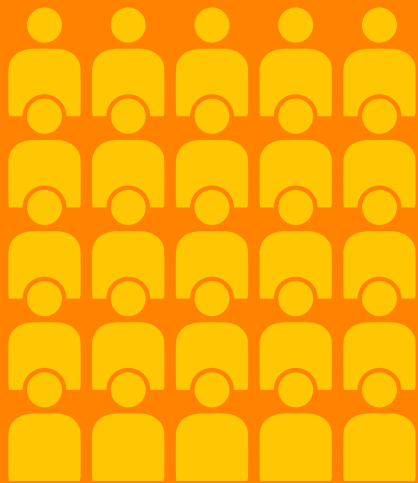
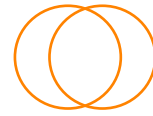

South Asia – which consists of Afghanistan, Bangladesh, Bhutan, India, Pakistan, Maldives, Nepal and Sri Lanka – is mostly a region of out-migration. It is estimated that are 13.9 million international migrants residing in the sub-region while some 43.4 million South Asians reside outside of their country of origin (UN DESA, 2020). 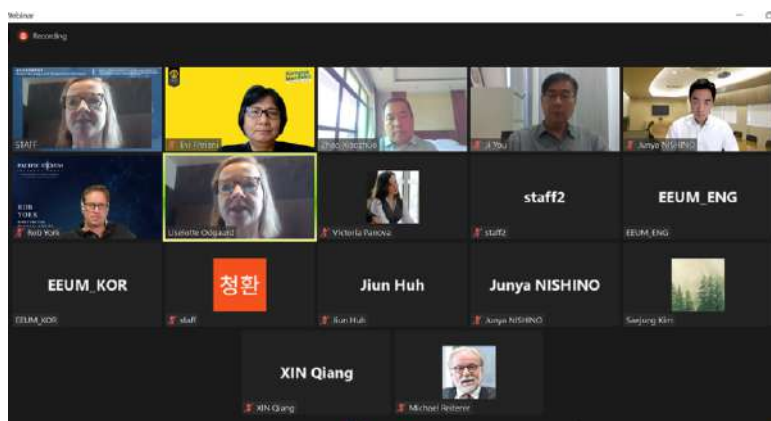

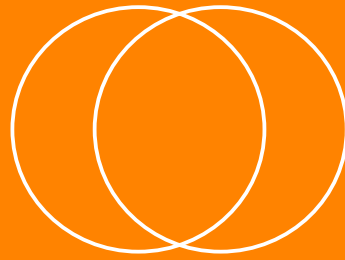

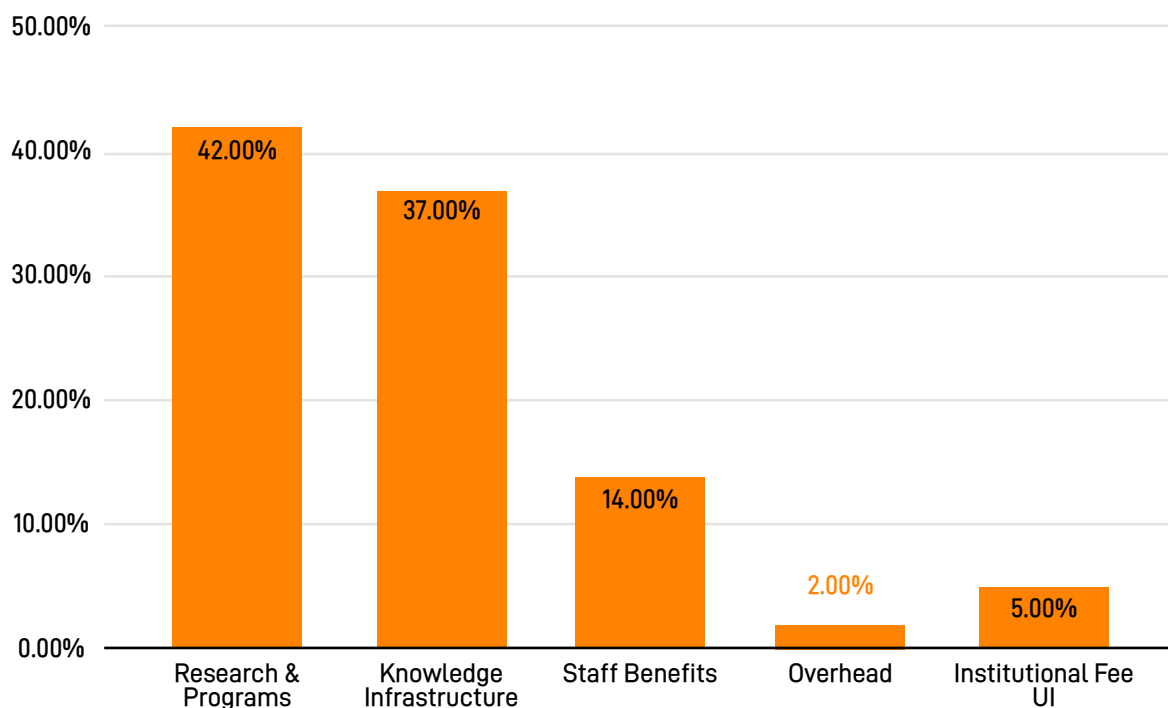
